#### 1. Welcome and introductions

#### 2. Review of Minutes IRG 2017

The minutes were accepted as an accurate record of the meeting. The following were noted:

- 2.1. Dizziness chart: No response had been received to join the group. However it was felt that this should still be pursued. Jorg agreed to contact other IRGs to encourage a group to form. He will also work with Ingo to prepare vignettes. The outcome from the group will be presented at the conference in Manchester in 2019. If there is still no interest to form the group, then this will not be carried forward from 2019.
- 2.2. OBGYN Task and Finish Group have reviewed the requirements and have concluded that the updated discriminators in the 3e will be sufficient to cover the requirements of the pregnant woman. However, further consideration will be given to the understanding of the role of the midwife in maternity triage and to the potential 'dispositions' via a PPM. This will be led by the OBGYN T&F group.

The OBGYN T&F group, led by Diogo will consider a maternity chart for specialist units. Jorg had suggested names for the group, Diogo will check and also invite other IRGs to nominate members. The chart will be presented at the 2019 conference.


2.3. MOUs and governance structure work will be carried out in 2018/2019.

3.1. Annual reports presented by all present IRGs. These will be uploaded onto the website for information.

## 4. General Discussion and questions

- 4.1. Thorocoabdominal chart. An update had been suggested by the Portuguese group. This will now go through a formal process for consideration with the scientific evidence being circulated with the minutes. Following review, IRGs will be asked to confirm if they feel that this is a critical issue. A mechanism will be set-up to consider this before Manchester 2019.
- 4.2. History of foreign travel. This was raised briefly by the Netherlands. Further information will be submitted for circulation and consideration as with 4.1 above.
- 4.3. Mental health charts. Following completion of an e-Delphi there are recommendations for updates to these charts which are currently being reviewed by Jill Windle prior to circulation and wider consideration.
- 4.4. Process for updates. We discussed the process for promulgating patient safety updates critically and agreed that the notifications should be completed as agreed with Wiley i.e. within 28 days from start to notification of all users:



We agreed that in order for this to happen robustly we need to know who is using it. We also felt that IT companies should be encouraged to include the opportunity for annual updates within their licensing fees. Sue will discuss both of these issues with Wiley.

We also agreed the importance of producing a statement to clarify the timeframe for implementation of these critical updates and 3-months was agreed. The statement will state that if the update is not implemented within that timeframe then the risk is with the users as their system is no longer supported. Sue will draft the statement and circulate for comments.

In addition, it was agreed that we should write an article that is multi-national and multi-author showing how the system works, is supported and how updates are notified and the actions that should be taken. It will also include information about the risks of using an unsupported system where updates are not implemented. All members will consider where we will publish this. Any members who are prepared to be involved in authoring the paper to contact Steph.

We also discussed **non-critical updates** and agreed that these should be agreed, enacted and embedded in a timely way and that they cannot wait for, for example, every three years. However, we have to consider publication methods and using IT more actively in the future. It was agreed that each IRG will consider this in their context for a wider discussion at Manchester 2019.

Finally, we agreed to produce a map of editions in different countries, indicating the Emergency Triage edition that these are based on.

## 5. Dates for next meeting

- 5.1. The next annual IRG meeting will be held in Manchester, with the IRG meeting and advisory group meetings on the 17th October 2019 and the MTS conference being held on the 18<sup>th</sup> October 2019. This will be the 25<sup>th</sup> Anniversary of the start of MTS.
- 5.2. 2020 and 2022 were also discussed and initial interest expressed from Spain for 2020 and the Netherlands or Italy for 2022. Each group will consider the requirement for a two-day meeting and then make a formal proposal if they still wish to be considered. Other countries who may be interested should also submit a proposal.
